### **Minutes of the proceedings of the Annual Meeting of Parishioners held at 6.30 pm in Coxhoe Village Hall, on Wednesday 7<sup>th</sup> May 2014.**

**1. Welcome** – Councillor P Dodsworth, Chair of Coxhoe Parish Council, welcomed everyone to the meeting and thanked them for their attendance.

**2. Minutes of the last Annual Parish Meeting held on 8<sup>th</sup> May 2013** – were agreed as a correct record and signed by the Chair.

**3. Parish Council Annual report and draft financial accounts for 2013/14** – The Chair advised that this was his seventh year as chairman of the Parish Council. He indicated that a comprehensive report had been circulated outlining progress made and work undertaken by the Parish Council during the last year. In summary he outlined continued support for FLiC and other community facilities. **7. Coxhoe Village Hall report** – The annual report for the village hall had been circulated. This gave details of the work they had undertaken during the year and anyone present was welcome to have a look around the Village hall. .

**8. FLiC report** – The annual report for FLiC had been circulated. This gave details of the work they had undertaken during the year and that they were on course to break even financially.
